INVITATION TO BID Two (2) Grader mounted rubber tire rollers

Sealed bids for the purchase of 2 (two) new 90" grader mounted rubber tire rollers for John Deere 670G graders that **DO NOT** have rear rippers. Hydraulic lift assemblies shall lift assemblies will be required along with quick attach capability. Bids will be received by the Dale County Commission at the Dale County Government Building, 202 South Highway 123, Suite A, Ozark, Alabama until **10:00 a.m., Wednesday, January 3, 2024**.

BIDDERS INSTRUCTIONS:

All bids must be signed, sealed and marked "BID ON GRADER MOUNTED RUBBER TIRE ROLLERS" with the opening date and time marked on the outside of the bid envelope.

Must use the attached **BID FORM** to list your price proposal. **BID FORM** page must be filled out in ink by an authorized agent and notarized.

If you do not meet specifications, please explain the deficiency for consideration. Any other exceptions must be clearly stated by the vendor in a separate attachment.

It is not the policy of Dale County Commission to purchase based on low bid only. Bid awards will always be in the best interest of Dale County.

Dale County reserves the right to award this bid to any number of responsive and responsible bidders. Dale County reserves the right to reject any and/or all bids.

BID SPECIFICATIONS for

Two (2) grader mounted rubber tire rollers

GENERAL

These specifications shall be construed as the minimum acceptable standards for two (2) grader mounted rubber tire rollers and two (2) hydraulic lift assemblies, with quick attach capability and accumulators. Should the manufacturer's current published data or specifications exceed these standards, the manufacturer's standards shall be considered minimum and shall be furnished. All integral parts not specifically mentioned in the scope of these specifications that are necessary to provide a complete working unit shall be furnished. Additionally, the machine offered for bid shall include all standard manufacturer's equipment. The rollers must be new.

BID FORM

Each bidder must submit his or her bid on the **BID FORM** included in the invitation to bid package. All written warranties to be submitted shall be attached to the **BID FORM**.

BID PRICE

The bid price shall include all destination charges, delivery charges, title fees, rebates, and all other applicable costs and refunds.

MANUALS

Each unit shall be provided with one (1) copy of operator's manual, one (1) copy of the repair manual, and one (1) copy of the current parts manual (Electronic version is acceptable), if applicable.

WARRANTY

Bidders shall submit a copy of all warranties.

Hydraulic Lift Assembly in lieu of a rear ripper

Must mount to the grader like a factory rear ripper without welds or holes to drill.

Must have an accumulator capable of setting to a minimum of 1,600 psi.

Lift cylinder must have a burst pressure of 6,000 psi and the cylinder must have a minimum 30-month factory warranty.

Must be manufactured in North America
