Commission Meeting Minutes - March 27, 2018

The Dale County Commission convened in a regular session Tuesday, March 27, 2018. The following members were present: Chairman Mark Blankenship; District One Commissioner Chris Carroll; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary; and District Four Commissioner Frankie Wilson.

Chairman Blankenship called the meeting to order at 11:00 am. Commissioner Wilson opened with the Pledge of Allegiance. Commissioner Carroll followed with prayer.

APPROVED - MINUTES – MARCH 13, 2018 - REGULAR SESSION

Commissioner McKinnon made a motion to approve the minutes of the March 13, 2018 Commission meeting.

Commissioner Carroll seconded the motion, all voted aye. Motion carried.

APPROVED – PROCLAMATION – CHILD ABUSE PREVENTION MONTH

Commissioner Gary made a motion to approve signing a proclamation for the month of April as Child Abuse Prevention Month.
