



# ***Dale County Commission***

## **Commission Meeting Minutes - May 19, 2020**

The Chairman cancelled the regularly scheduled meetings for May 12, 2020 and May 26, 2020. The Chairman then called a meeting for May 19, 2020 to replace the two meetings. The Dale County Commission convened in a called session Tuesday, May 19, 2020. The following members were present: Chairman Mark Blankenship; District One Commissioner Chris Carroll; District Two Commissioner Steve McKinnon; District Three Commissioner Charles W. Gary and District; and Four Commissioner Frankie Wilson.

Chairman Blankenship called the meeting to order at 10:35am. Commissioner McKinnon opened with the Pledge of Allegiance. Commissioner Carroll followed with prayer.

### **APPROVED – AGENDA**

Commissioner Gary made a motion to approve the agenda adding the position of Solid Waste Compliance Officer under Personnel.
